London Diamond Bourse Membership Terms and Conditions

Eligibility and Admission

- 1.1 Membership is available to subscribers of the Company's memorandum and those approved by the Council under the Rules
- **1.2** Applicants must be at least 21 years old and have worked in the Diamond and Jewellery Trade for at least two years prior to application.
- 1.3 Applicants must have a UK registered company
- **1.4** Applicants must have traded with at least two current members of the LDB or have three trade references, or have been enrolled on the LDB mentor programme for two years.

Application and Acceptance

- 2.1 Applications for Membership must be made to the Council as per the Rules. *
- 2.2 Applicants will be required to undergo a membership interview, identity check, and a two-week holding period.
- **2.3** Applicants must hold current jewellery insurance
- 2.4 Membership is granted upon acceptance by the Council and inclusion in the Register of Members.

Member Obligations

- 3.1 Members must comply with the Rules and Regulations of the London Diamond Bourse. *
- 3.2 All Members are personally liable for all obligations, including those undertaken through a company.
- **3.3** Members must enter a Guarantee and Indemnity agreement.
- 3.4 Payment of yearly subscription must be paid prior to commencement of membership
- **3.5** Monthly standing order payments will be accepted subject to approval prior to commencement of membership and must be paid on the 1st day of the month
- **3.6** If any Member shall fail to pay his Subscription on the Annual Subscription Date or any additional fee on its due date the Council may terminate their Membership on not less than 5 Business Days' notice.
- **3.7** Without prejudice to the provisions of Rule 3.6 if any Subscription or any additional fee is not paid on its due date the Council may suspend a member and refuse them entry to all facilities and premises of the LDB for such period as the Council may decide.

Term and Termination

- **4.1** The Membership year runs from 1st October to 30th September.
- **4.2** Members commit to a one-year membership, if joining part way through the year this will be pro-rata
- **4.3** Members may resign by providing 30 days' notice, effective from 30th September (resignations must be received in the office no later than the 1st September).
- **4.4** The Council may terminate Membership for reasons including the termination of employment with a company, dissolution of the company, or termination of the Guarantee and Indemnity.
- **4.5** The Council may establish different tiers of Membership and adjust Regulations as needed.
- **4.6** Members may upgrade tiers during a membership year but may not downgrade.
- **4.7** Membership is personal and non-transferable. It terminates upon death, bankruptcy, resignation, or as per the Rules.

Use of Membership

- **5.1** Members may refer to their Membership to the LDB in communications, subject to Council approval.
- **5.2** Upon termination, Members must immediately cease using references to LDB and delete all related materials, from invoices, websites and social media.

Representation

6.1 Members have no authority to represent or bind the LDB without prior written consent from the Council.

Liability and Acknowledgement

- **7.1** Members acknowledge and agree to personal liability for all obligations, whether incurred personally or through a company.
- 7.2 By applying for Membership, Members confirm they have read and accepted all Rules and Regulations of the LDB.
